Re: Our brief discussion regarding the release of the above reference project funding has reference.

Grand us the opportunity to greet you in service of our fellow man with acknowledgement of your personal commitment and contribution.

History:

- 1) The funds were recruited on foundation of a pre-arrangement/approval from the South African Reserve Bank for 500 billion USD/Euro. Refer to Annexure 01.
- 2) A contract was concluded on 2nd September 2022 regarding the project funding. Annexure 02.
- 3) On approximately the 23rd September 2022 a first tranche of €50 billion Euro was send via MT103 cash transfer to FNB Account Num 62827123770 with **Branch Code 256055**. Annexure 03.

FNB did not inform us as client of receipt of funding which they were/are obligated to do in terms of regulations related to the current “Law” since.

On return to South Africa **(a)** FNB deny receipt of funding for projects, **(b)** we were obligated to pay FNB bankers to trace the funding sent from BNI Indonesia, **(c)** we were informed of software programs in existence to alter the receipt files via SWIFT to “proof illegitimacy of funds received.”

The transaction is confirmed by the Global Server (Annexure 06) 28th November 2024.

Attached as Annexure 03 are the MT103 retrieved by a banker confirming the receipt of the funding certified by a banker within FNB.

We were approached by family members of the SARB Governor to assist release of funding for an allocation of 30% of the funding to inappropriate courses/sources.

- 4) It is noteworthy to notice that the funds were sent to the account reference in item 3 above but reporting is being done against Branch Code **255005** which represents FNB Securities Trust, which is not allowed to receipt the **cash funds** according to the FNB Security Trust publication Attached as Annexure 05.
- 5) An attempt to open a criminal investigation case was/is blocked by the South African Police Service, with feedback that the President of South Africa is implicated and approval for investigation is subject to his authorisation.
- 6) During a meeting with the CEO of FNB's Relationship Manager Me N Koch (Annexure 07), Me Koch let it slip the FNB was trading with the funds realising \$1 billion USD per day from the said trade of the €50 billion Euro per day. (Several Witnesses)
In pursuit to have the funding released, aforementioned disclosure confirmed that the €50 billion Euro fund was not returned as claimed by the terminal shots falsified, but traded by FNB. Refer to Annexure 08
We were informed that the unplanned disclosure was the reason for Mr Jaques Cilliers golden handshake and the one-sided termination of the referenced account in item 3 above.
- 7) Many people are forced into crime in attempt to avoid starvation, while approximately 70% of youth are un-employed due to insufficient funding to support economic growth while "unlimited opportunities" exist.
- 8) We asked for urgent assistance to the release of the funds for projects, and the prosecution of the offender(s)?
- 9) Hundreds of similar cases of smaller amounts await address, which support is impossible to recruit in South Africa.

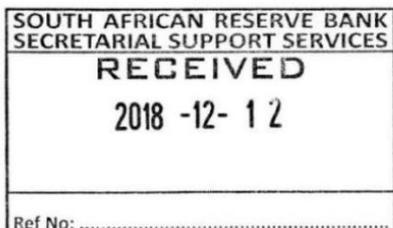

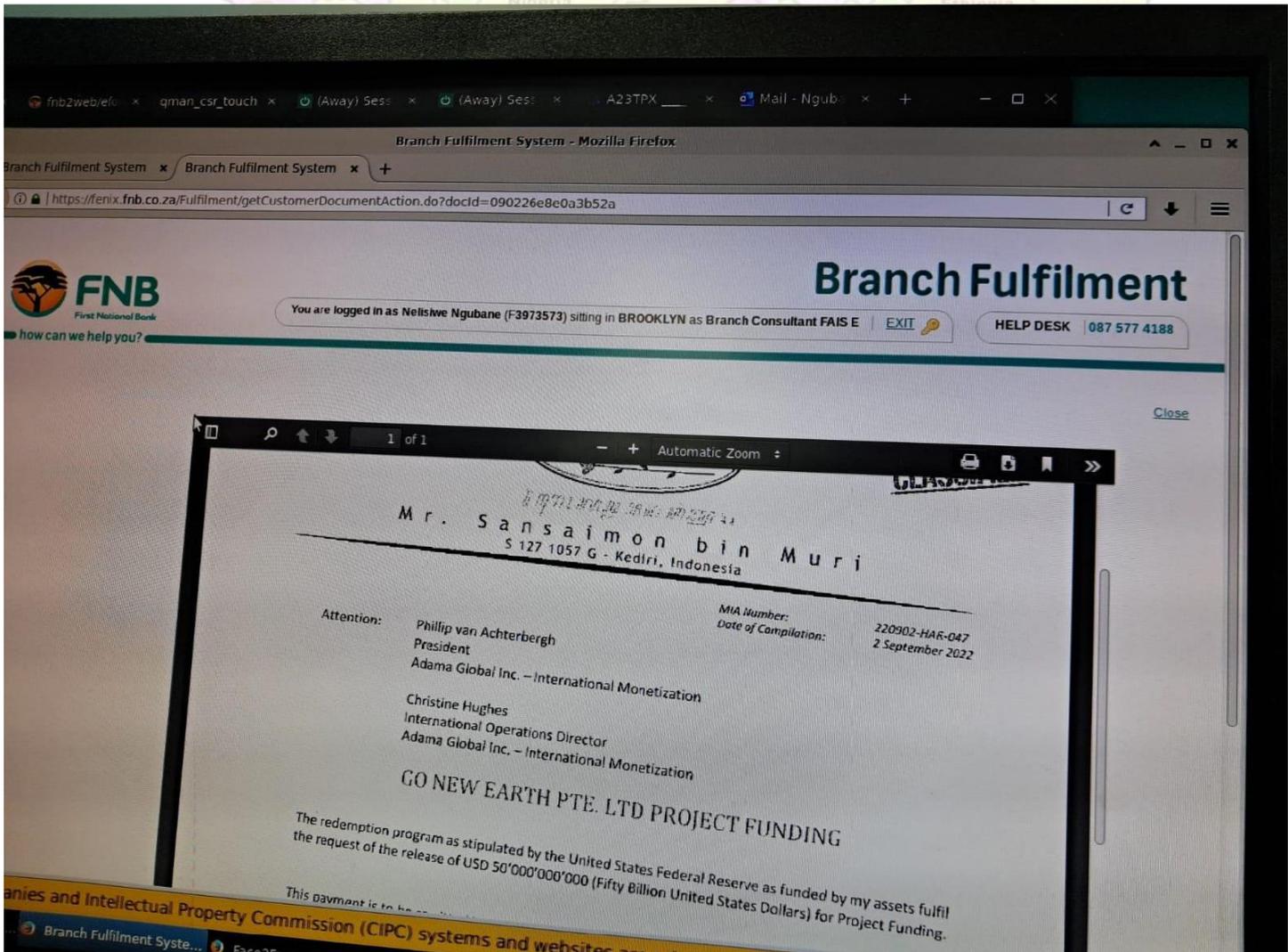
