Born	Robert Ciro Gigante March 14, 1929 Chicago, Illinois, U.S.
Died	December 31, 2013 (aged 84) Hillsborough Township, New Jersey, U.S.

“For the 1994 Election, Grant did daily rants against [] New York Governor Mario Cuomo, who he was now calling ‘the sfaccim.’ Grant had been friends with Cuomo beginning in the seventies, but they had a falling out during an appearance in 1986 on Grant's show. Grant questioned Cuomo on why he needed a large war chest against an opponent who didn't have much money, and Cuomo hung up on Grant. In 1994, the ‘Mario Salute’ became a staple of Grant's show. Listeners would call in and state, ‘Mario, ascoltami! Tu sei proprio un sfacim.’ Grant explained the translation in English was, ‘Mario, listen to me. You're a real lowlife.’ T-shirts and bumper stickers were created with anti-Cuomo messages. A listener also made an anti-Mario Cuomo song which Grant would frequently play. Grant campaigned for Cuomo's opponent, George Pataki and had him on as a guest many times allegedly leading to Pataki picking up enough votes to defeat Cuomo.”

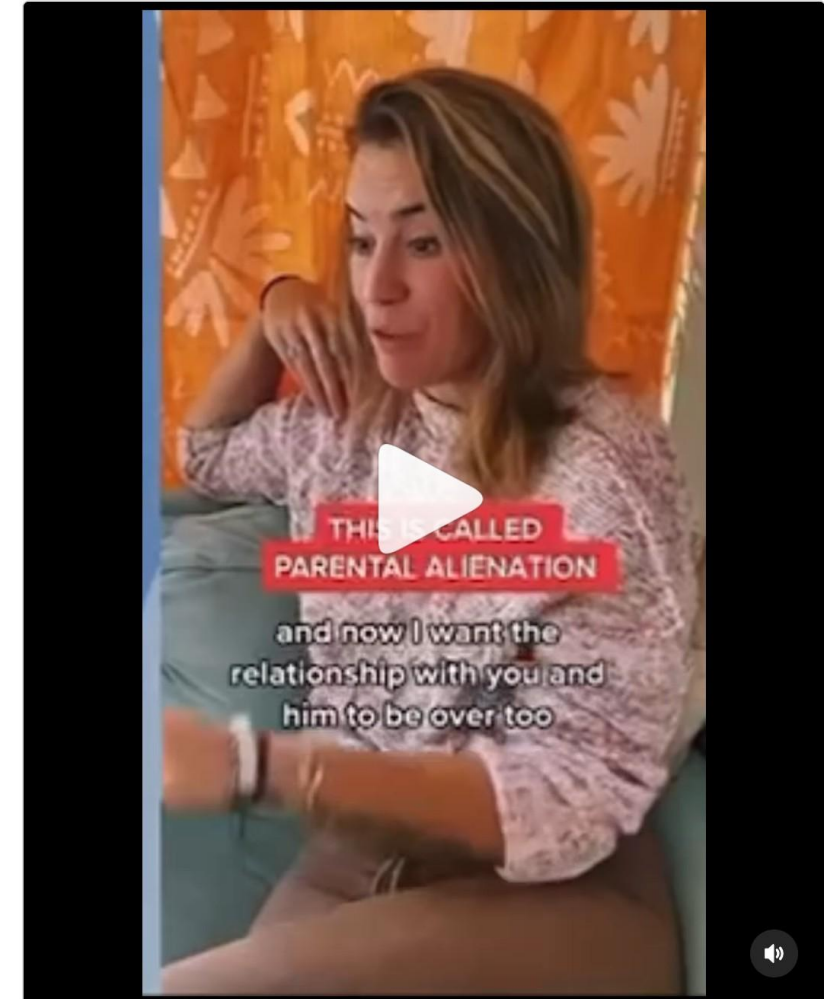

Fifth Amendment

No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising in the land or naval forces, or in the Militia, when in actual service in time of War or public danger; nor shall any person be subject for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation.

How to Fight the System (cont'd)

Fourteenth Amendment

Section 1: All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; **nor shall any State deprive any person of life, liberty, or property, without due process of law**; nor deny to any person within its jurisdiction the equal protection of the laws.

Section 3: **No person shall** be a Senator or Representative in Congress, or elector of President and Vice-President, or **hold any office, civil or military**, under the United States, or **under any State**, who, **having previously taken an oath**, as a member of Congress, or as an officer of the United States, or **as a member of any State legislature**, or **as an executive or judicial officer of any State**, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

How to Fight the System (cont'd)

Brokaw v. Weaver, 305 F.3d 660, 665 (7th Cir. 2002)

In that case, Nesses brought suit in federal court against the lawyers and some of the judges involved in a breach of contract case which he had filed in Indiana state court and lost. *Id.* at 1004. Nesses claimed that his opponents' lawyers used their political clout to turn the state judges against him. *Id.* The district court dismissed Nesses' suit for lack of jurisdiction based on the *Rooker-Feldman* doctrine. *Id.* This court rejected that conclusion, reasoning that the *Rooker-Feldman* doctrine did not bar Nesses' claim because his suit was not premised on a claim that the state court judgment denied him some constitutional right; rather, his federal claim was based on a right independent of the state court proceeding. As we explained in *Nesses*, any other conclusion would mean that "there would be no federal remedy for a violation of federal rights whenever the violator so far succeeded in corrupting the state judicial process as to obtain a favorable judgment,...." *Id.* at 1005. Moreover, we reasoned that such a "result would be inconsistent with cases in which, for example, police officers are sued under 42 U.S.C. § 1983 for having fabricated evidence that resulted in the plaintiff's being convicted in a state court." *Id.*

How to Fight the System (cont'd)

Determining a Relative's Specific Relationship to a Child and the Relative's Degree of Consanguinity to That Child's Parent or Stepparent

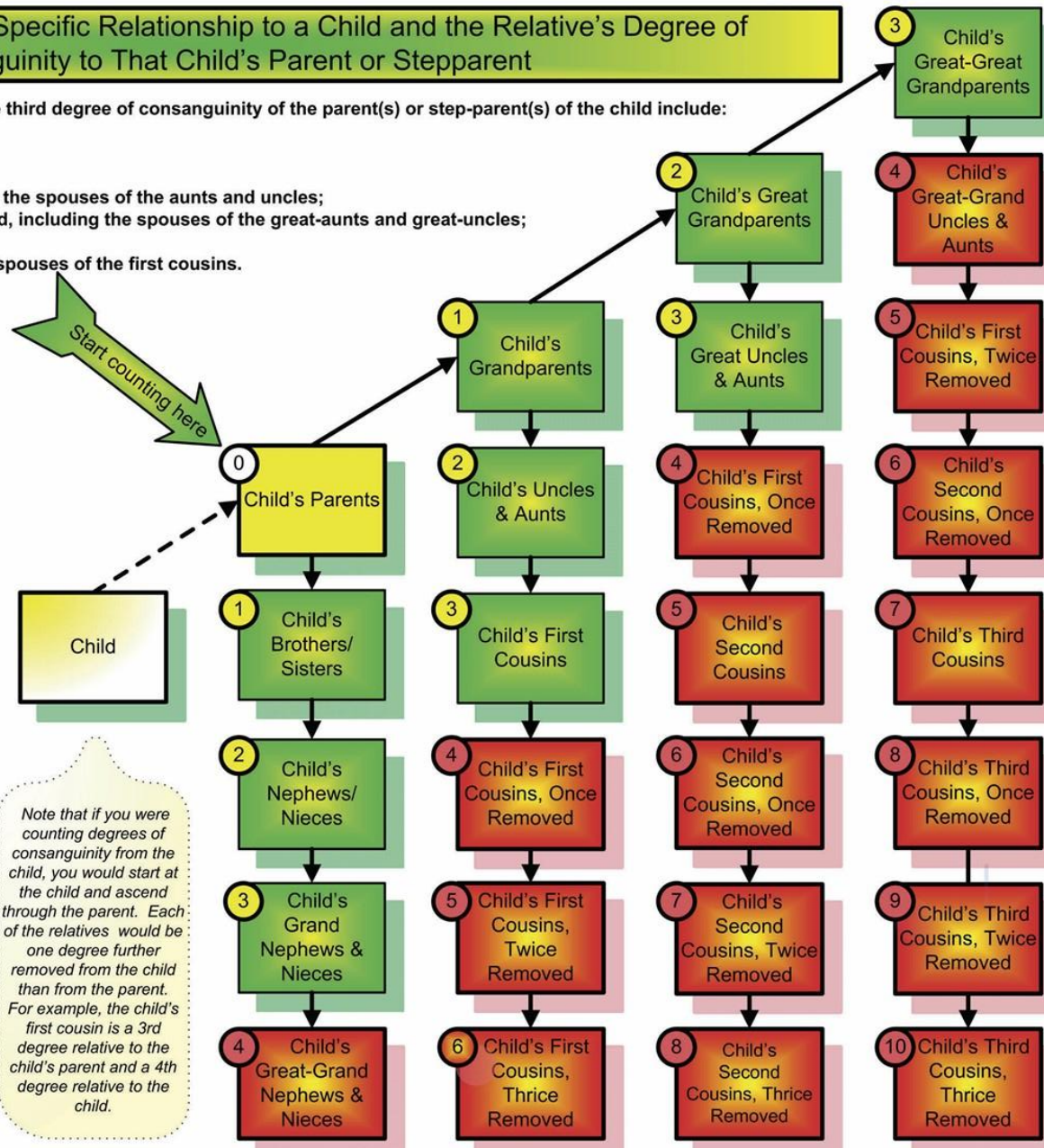
18 NYCRR 415.1 (h) (1) (iii)...Relatives within the third degree of consanguinity of the parent(s) or step-parent(s) of the child include:

- the grandparents of the child;
- the great-grandparents of the child;
- the great-great-grandparents of the child;
- the aunts and uncles of the child, including the spouses of the aunts and uncles;
- the great-aunts and great-uncles of the child, including the spouses of the great-aunts and great-uncles;
- the siblings of the child; and
- the first cousins of the child, including the spouses of the first cousins.

The numbers attached to each relative in the consanguinity chart below represent that relative's degree of consanguinity to the child's parent. To understand how these numbers are derived:

- Locate on the chart, the child's parent and the specific relative who is providing the child care.
- Determine the relative's degree of consanguinity to the child's parent, by starting with the "child's parent" and following the arrows.
- Count *upwards* to the common ancestor shared by the parent and other relative, and then *downwards* to the specific relative, (if the relative is a direct descendant of the child's parent, such as the child's brother, you will not need to count upwards.)
- Count a degree for each relative you *pass through* to get to the specific relative, meaning those *between* the parent and relative. Do *not* count the starting point, which for determining "relative care" is the child's parent.
- The degrees they stand from each other is the degree of consanguinity by which they are related.

Thus, from the child's "parent" to the child's grandparent, 1 degree; child's parent to the child's aunt/uncle, 2 degrees; child's parent to the child's great grandfather, 2 degrees; child's parent to the child's first cousin, 3 degrees.

How to Fight the System (cont'd)

1. Avoid participating to the extent possible, Q.
2. If dragged into court by governmental agents (police, hired “guns,” clones, etc.) rebut all presumptions.
3. If stopped by police while driving, take initiative in questioning.

How to Fight the System (cont'd)

Presumption of Regularity

The law presumes that everything is as it should be: the judge, court personnel, court appointed experts/individuals, prosecutor, police, witnesses, jurors, etc., are all honest and do not have conflicting loyalties with the U.S. Constitution.

Ask: “Have you ever been affiliated with a secret society, club or cabal, to include without limitation, freemasonry and order of the eastern star?”

How to Fight the System (cont'd)

Three Possibilities

Yes: Ask specific questions. Which one(s), how long, positions, take oaths, get copies, names/relationships of other members (brother/sister), etc.

No: Take them at their word.

Refuse to Answer: Repeat your question at least three times.

How to Fight the System (cont'd)

If dragged into court

Regardless of their responses:

1. Order a copy of the transcript (court reporter), get actual electronic copy if possible, follow all steps to certify transcript.
2. Send copy of certified transcript to local FBI office with explanation that, "On information and belief, the individual(s) in question have conspired to deny you your constitutional rights under the Fifth and Fourteenth Amendments through affiliation with a secret society, club or cabal that is hostile to the government and interests of the United States of America and its citizens, including me." (procedural and substantive due process clauses)

How to Fight the System (cont'd)

If pulled over while driving

Why did you pull me over?

VTL only applies to commercial vehicles.

Why do you believe I am engaging in commerce?

I'm exercising my federal constitutionally protected right to travel.

Show him/her DOT Card.

NEVER say you "understand."

Say: "I comprehend the words you use, but refuse to stand under your authority."

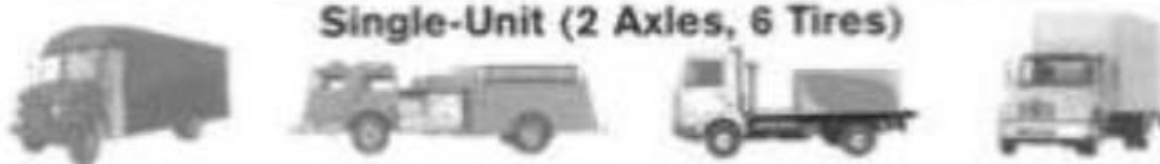

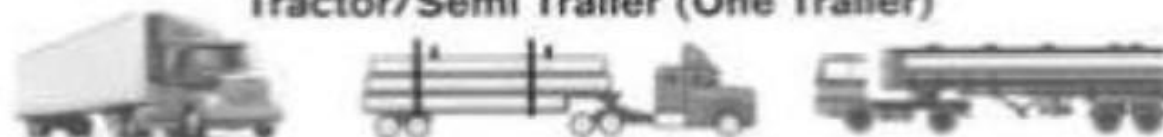
