

**Legal Affidavit of Ciaran Daniel Buchanan (aka Kevin Daniel Annett)  
regarding my present circumstances**

**Issued on April 10, 2021**

I make this statement freely, being of sound mind and body. I have personal knowledge of the events described herein.

1. I am a Canadian citizen residing at 260 Kennedy Street in Nanaimo, British Columbia. My occupation is a retired clergyman and human rights consultant.
2. My father is an American citizen living in Daytona Beach, Florida. He is 92 years old and suffers from an acute aortic aneurism. I am his sole family support and his legal executor with full power of attorney over his affairs.
3. Throughout the month of March, 2021, I was informed by my father and his physician, Dr. Caridi of Veterans Affairs in Daytona Beach, that his condition was worsening and my presence was urgently required. I was given a letter from Dr. Caridi and others to that effect.
4. On Tuesday, March 30, 2021, at the request of my father and Dr. Caridi, I attempted to enter the United States by car at the Blaine, Washington border crossing. This occurred between 10:10 and 11:00 am. I requested admission to the United States on compassionate grounds to attend to my ailing father. My request was denied.
5. While being interviewed by the US Border and Customs officials I never left my vehicle. Accordingly, I was assured by those officials that I had not entered American territory and therefore would not be required to quarantine after I checked in with the Canadian customs officials. I was given a notice to that effect by one of the American officials.

6. When I stopped at the Canadian customs station on my return, I explained these facts to the border officer, a young woman in her twenties. She nodded, read the notice I was given, and after checking my passport and documentation she returned to me my passport and said *"You're free to go"*. I asked her if I was required to quarantine and she said, *"No, you're clear"*. I then drove away and returned to Nanaimo.
  
7. At approximately 8:00 AM on the following Friday, April 2 – three days after my encounter at the border - I received an email that claimed to be issued by the Government of Canada. It stated falsely that I had just returned to Canada from another country and was expected to undergo a fourteen day COVID quarantine. I was shocked and alarmed that this email was a misrepresentation of the facts and contradicted what both American and Canadian border officials had told me in person three days earlier. It also violated my right of free and informed consent to any medical procedure enshrined and guaranteed under international and common law.
  
8. In response, for over two hours I tried phoning and emailing various COVID departments to seek clarification and correct their inaccuracy. I was unable to speak to anyone save one individual with the COVID information line. When I tried to explain my situation he barked *"Just comply, you're expected to quarantine"*, and hung up on me abruptly.
  
9. Despite this, and the email's inaccuracies, I complied with its requirements and immediately quarantined myself, including by phoning in my condition report every morning to the number provided in the email. My hope was that after the fourteen day period I would be able to clarify what I assumed was a bureaucratic mishap or error that unnecessarily ordered me to quarantine and violate my rights.


10. On the morning of Monday, April 5 – Day Three of my quarantine - a change in my domestic situation required that I find a quarantine location more in line with the government's COVID requirements. I realized as well that the new requirements compelled me to undergo a Corona test on Day Ten of the quarantine and so I planned to obtain that kit and relocate to a nearby alternative quarantine site where I would be alone. My partner and co-domicile Lori O'Rorke agreed that this would be a good step. Masked and distancing, I obtained the kit and immediately relocated to the new quarantine site that same day.
11. The next morning, Tuesday April 6 – Day Four of my quarantining – a man came to my home at 260 Kennedy street. He claimed to be a "security consultant" with the Government and inquired if I was quarantining. Lori replied "*Yes, but not here*". The man asked her where I was and Lori replied, "*I don't know*". Lori then asked him for his name and some identification but the man refused, creating a doubt about his authenticity. He said "*I'm with a private security firm that has a long history of working with the government*", but he wouldn't name the firm. The man returned to his car and according to Lori spent twenty minutes filling out paper work before he left. At no point after that did the same man or anyone else attempt to phone me concerning my place of quarantine.
12. Two days later, on April 8 – **Day Six** of my quarantine - I received a second email allegedly from the Government that was as shocking and untruthful as the first I had received. The second email claimed inaccurately that I was now at **Day Ten** of my quarantine and therefore had to undergo a Corona testing by the end of the day or face fines or imprisonment! Once again I tried contacting someone in government to clarify this misrepresentation but was unsuccessful.

13. At this point I was profoundly disturbed. The contradictory and untruthful communications I had received from the government, the unusually delayed response time of three days, and the refusal of the security agent to identify himself or phone me made me realize that I was being defrauded and lied to. I could not understand the motive behind such behavior. However, I did know that in legal terms willing participation in a fraud is an offense under the law and should be avoided. Confused, I nevertheless continued to quarantine and prepared to perform the Corona test.
  
14. Unfortunately, just over three hours after I received the second inaccurate email, things became even more absurd. My cell phone stopped functioning and my laptop crashed and did not recover. As well, a friend who attempted to bring me money from my bank account that same day told me that the withdrawal was declined by the ATM. I found it difficult to believe that these attacks were unrelated to the other events of that day and prior. I genuinely believe and have experienced that these events constitute an ongoing assault on me, for reasons and by actors unknown.
  
15. Despite these attacks I have continued to quarantine and follow the COVID guidelines. I am now at Day Eight of the quarantine period and in two days I will perform the required Day Ten corona test. As of today, no officer of the Government or its COVID agencies has contacted me in response to my inquiries and situation, either by phone, email or in person.
  
16. As the public record shows, I have had a long personal history as an informed critic and outspoken opponent of the federal government, including its involvement in committing and concealing<sup>3</sup> genocide in Canada. Just prior to these extraordinary events. I helped a human rights coalition issue a Public Summons to several Canadian government officials for their alleged complicity in these crimes, including to Bill Blair, the Public Safety Minister who is responsible for COVID quarantining. Whether the fraud and attacks

perpetrated on me since April 2 are related to these actions and to the Summons issued to Mr. Blair is a matter for a court of law to ascertain.

17. At present, I am facing wrongful arrest and confinement despite having abided by the quarantine requirements related to the Corona virus. I do not now nor have I ever suffered from any of the symptoms of the Corona virus. I am therefore asking that the government's COVID agency stand down from any course of retributive action against me until their perplexing and fraudulent actions are explained, and this matter can be amicably resolved. Until then I am following all COVID guidelines and expect the government to similarly obey their own laws and my civil liberties and rights as a law-abiding citizen, including my unalienable right of free and informed consent to any medical procedure or testing.

18. For the record, this matter is filed as a Private Information in the British Columbia court system and in international courts of justice. My case is now before several human rights Tribunals and the agencies and Member States of the United Nations, all of which are actively monitoring the outcome of these events.
